## **REQUIREMENTS FOR MULTIPLE-ENTRY VISA FOR NATIONALS OF INDONESIA, THE PHILIPPINES, AND VIETNAM (For Sightseeing/Visiting Friend(s) or Relative(s)/Business purposes)**

### **Eligibility for applicant**

Possesses an ordinary MRP (Machine Readable Passport) / e-passport in compliance with the ICAO standard, AND is one of the following:

| TYPE A | Individual who has proof of travelled as a temporary visitor to Japan in the last three years and who has the ability to pay his/her travel expenses                                |
| TYPE B | Individual who has a proof of travelled as a temporary visitor to Canada, France, Germany, Italy, United Kingdom or United States of America multiple times in the last three years |
| TYPE C | Individual with sufficient financial capacity   |
| TYPE D | Spouse or children of the individuals who are mentioned (A-C) above   |

### **Required Documents:**

- 1 Valid current passport  
(if you have travelled to Japan, Canada, France, Germany, Italy, United Kingdom or United States of America multiple times in the last three years, please also submit any previous passports documenting this travel)
- 2 One passport size photograph, taken within the last six months
- 3 One completed original visa application form
- 4 Bank statements for the last six months with name and address clearly shown
- 5 Letter from your employer stating the period of your employment and salary (if you are self-employed, a copy of your "Company Registration Certificate" and a document showing your yearly earnings)
- 6 Income certificate from IRD
- 7 Letter of explanation stating the reason of applying for the multiple visa

- 8 In the case of a spouse or child with no independent income, proof of kinship (birth certificate, marriage certificate etc.) with the principal applicant will be required
- 9 Visa fee (if applicable) – due when the visa has been issued

\*Type B applicants should submit documents 1, 2, 3, 5, 6, 7 and 8 from the above list, plus a document proving current address in New Zealand.

**Please note:**

- ◆ You should not apply earlier than 3 months before arrival into Japan
- ◆ Each stay will be up to a maximum of 15 or 30 days, at the discretion of the Consulate
- ◆ We may issue a single-entry visa after visa examination
- ◆ Additional documentation may be required.
- ◆ No documents other than your passport will be returned.
- ◆ Multiple Visas will take a minimum of five working days to process.
- ◆ Possession of a visa does not entitle the bearer to enter Japan upon arrival at port of entry if he or she is found inadmissible.
