REQUIREMENTS FOR MULTIPLE-ENTRY VISAS FOR NATIONALS OF CHINA

The result of examination could be single entry visa

There is no guarantee that applicant can obtain multiple entries Visa

- Examination will be initially processed by the submitted documents
- The applicant may be required to submit additional documents if needed
- You should not apply earlier than 3 months before arrival into Japan
- New Zealand Student Visa, Guardian Visa and Working Holiday visa holders cannot obtain this visa unless their parent or spouse obtains the visa jointly or in advance
- ALL visa applicants MUST appear in person either when applying for visa OR at the collection of visa

THE FOLLOWING MUST BE SUBMITTED WHEN APPLYING FOR A VISA Please ONLY bring the documents on the list below

- 1. Valid passport with valid New Zealand Visa:
 - ➤ Any types of tourist visa holder cannot be apply
 - print out your valid New Zealand Visa (Resident/Work)
 - transfer your NZ visa when you renew your passport, otherwise we can't accept your visa application (no exception)

*New Zealand Student Visa holders cannot obtain this visa unless their parent or spouse obtains the visa jointly or in advance

- 2. One passport size photograph:
 - ➤ Please use a professional service
 - NZ standard passport size OR 45mm x 35mm size
 - > must be taken within the *last SIX months*
 - DO NOT ATTACH WITH STAPLE OR TAPE

3. One completed original visa application form:

> please leave a section blank if you are unsure or if it doesn't apply to you

4. Proof of sufficient financial capability:

New Zealand bank statements for *last 3 months* (saving, investment etc...) with applicant's name and residential address on it

5. Proof of Employment (if applicable):

- > issued by the HR or your superior
- > stating the period of *your employment and salary* (if you are employed)
- > must be attention to "the Consulate-General of Japan in Auckland"
- we are **NOT** accepting your employment contract / job offer letter

6. Proof of your income from IRD (if applicable)

if you are employed

7. Letter from the applicant:

explanation from the applicant stating the reason of applying for the multiple-entry visas

8. The proof of relationship:

birth certificate / marriage certificate if the applicant applies with a children or spouse

9. Visa fee:

> due when the visa has been issued

Please note:

- ◆ DO NOT STAPLE/POSTIT THE DOCUMENTS
- ♦ Application open from 3 months prior to your entry date of Japan
- ♦ Additional documentation may be required
- ♦ No documents other than your passport will be returned
- Multiple Visas will take a <u>minimum of five working days</u> to process, please allow plenty of leeway
- ♦ There is NO urgent or priority visa processing services
- ♦ Possession of a visa does not entitle the bearer to enter Japan upon arrival at port of entry if he or she is found inadmissible
